\$23.7M

Pinellas County – 2018 - Representing a **Condominium Association** against Citizens Property Insurance Corporation in a **Large Loss sinkhole claim** involving 120 buildings that the Insurer originally denied. The judgment awarded by the jury against Citizens Property Insurance Corporation is one of the largest in Citizens' history. The Tampa Bay Times described the case as "monumental bad faith."

\$15.9M

Pasco County – 2013 – Representing the **Policyholder/Owner** of a 14-building apartment complex against Citizens Property Insurance Corporation following the denial of a **Large Loss sinkhole claim**. The case resolved three weeks before the scheduled trial date due to the Court granting the summary judgment motions filed against Citizens. The Miami Herald reported the settlement as one of the largest recoveries against Citizens as of that date.

\$9.1M

Seminole County – 2019 - Representing a **Condominium Association** in a **Large Loss sinkhole claim** involving 11 buildings that the Insurer originally partially denied and undervalued.

\$6.4M

Pinellas County – 2020 – Representing a **Condominium Association** in a **Large Loss hurricane and sinkhole claim** involving 12 buildings that was originally denied by the Insurer.

\$3.5M

Volusia County – 2019 – Representing a **Condominium Association** in a **Large Loss hurricane claim** involving a high-rise building.

\$3.35M

Palm Beach County - 2021 - Representing a **Condominium Association** managed by a Licensed Community Association Manager in Boca Raton, FL that suffered significant damage due to **Hurricane Irma**. The insurance company refused to cover our client's losses stemming from **storm damage** that impacted 63 units in a 12-story oceanfront condominium building. Our team of trial lawyers aggressively investigated and litigated the claim, finally resolving the case for \$3.35 million.

\$2.3M

Volusia County – 2020 – Representing a **Condominium Association** in a **Large Loss hurricane claim** after the Insurer valued covered damages below the deductible. The multi-million-dollar appraisal award for the Insured has resulted in a bad faith claim against the Insurer for “low balling” its estimates.

\$2.05M

Orange County – 2016 - Representing a **Policyholder/Owner** of a townhouse in a **fire claim**. The Insurer asserted arson and fraud charges against the Insured. The full property damage repair estimate along with \$1.8 million in bad faith damages was recovered on behalf of the Insured.

Osceola County – 2019 – Representing a **Condominium Association** in a **Large Loss catastrophic collapse claim** after the Insurer failed to pay the amounts necessary to properly repair the damaged building.

Hillsborough County – 2015 – Representing a **Policyholder/Owner** of a multi-building apartment complex in a denied **sinkhole claim**.

Marion County – 2018 - Representing a **Homeowners Association** in a **sinkhole claim** involving an apartment building that was originally denied by the Insurer.
